## 93:9/16 Junior Reps Report Carol Smith read a Report from Martin Matkin -

Names for the EMAS Training this year have been finalised and we have submitted 4 Juniors to take part. You can Select 5 but some couldn't commit, so only 4 were Selected.

Dates for Indoor Junior Shoots and JeDiS have been circulated, and we can ask Tom to get them on the Website.

### 94:9/16 **Development Officers Report** Jayne Curnock –

Judge Funding: Jayne has spoken to Caroline and Alan EMAS are to give archers that become Judges money to cover the cost of buying the Uniform. Judges can currently claim £50 a year from EMAS for Expenses (don't know what this covers), which EMAS may increase to £100 Annually.

**Proposal for September County Meeting:** County reimburse the archer when they attend the AGB Candidate Judge Seminar = £40

County also purchase the Equipment Pack (Rule Books, whistle, magnifying glass etc. approx £50) for the Candidate Judge. This pack remains the property of LRCAA until the Candidate passes their Judging Exam.

### **Comments from the Meeting:**

**Kim Copson:** I don't think we should do both as it could be quite costly for the County – if 10 people say they'll go to the Seminar that's £400 for the County to pay out, & then they may decide Judging's not for them! **Carol Smith:** AGB are stating you have to attend a 2 day Seminar or they can't put themselves forward to become a Judge! – but EMAS are saying they'll pay £50 - £100 towards this anyway.

**Martin Dexter:** what's in the Judges Packs? As Kieran put his own together on recommendations from more experienced Judges, so what's in the Pack may not suit everyone?

John Brooks: perhaps say we'll support 2 per year?

**After some discussion on this,** it was decided we need a breakdown on costs & to have all the information, then we can discuss what's involved & how long it takes, before making a decision.

Maybe do something like the County Coach Funding? Because we want to encourage people to become Judges as without them, Clubs can't hold Shoots!

Indoor Novice Shoot is on Saturday 14<sup>th</sup> January 2017. Entry Form has been updated with closed to L&R archers only, as we did get people trying to enter from outside the County. Entry fees were £6 and £4, do we leave these the same? Wreake Valley A have increased their hourly rate to £40/hour.

Mark Lantsbury: need to know the costs from last year really to give an idea.

Eddie Pemberton: we'll ask Jayne to bring that to the next T/O Meeting to decide.

Jayne is going to email out to Coaches and Clubs to gauge demand for Level One and Two Courses next year.
